## Subject: Nomenclature of Administrative Posts

## 1. Purpose

To harmonise and bring uniformity in the nomenclature of various administrative units and posts with the applicable norms, the following shall be used for all purposes. Concerned staff members shall change their signature/details and use the nomenclature accordingly. The functional areas or assignments given to concerned staff members shall be appropriately changed by the Office of the Registrar and kept in the personal file of Individual staff members. In case of clarification, the concerned staff member may approach the Office of the Registrar.
